## **Introduction:**

In early June 2004 the German Government is hosting an international Conference designed to further the use of renewable energy across the world. The conference will bring together Government, industry and civil society and will have three main outcomes.

- A political declaration describing common political objectives, offering a vision of how renewable energy can play a greater role in a more efficient and sustainable energy system, and including agreements on a follow-up process
- An international action plan in which various governments and actors propose concrete actions and voluntary commitments/goals for developing renewable energies
- Guidance for good policy leading to greater impact and increased coherence of the policy strategies employed

## **NGO Involvement**

Non-Government Organisation have been involved in the promotion of renewable energy for decades. They are dedicated to their use as an alternative to the burning of fossil fuels and the use nuclear power. The increasing awareness of the damage caused by global warming makes it imperative that immediate action is taken to rapidly introduce alternative fuel sources and to reduce global energy demand, in particular in Northern countries. This conference is therefore seen as an vital opportunity.

### Conference:

The conference is being organised by the German Federal Ministry for Economic Cooperation and Development (BMZ) and the German Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU). To assist them and International Steering Committee (ISC) has been established. This is made up of 55 representatives from Governments, international bodies, industry, NGOs etc. There are three NGO representatives: Jennifer Morgan – WWF; Shelia Oparaocha- Energia; Steve Sawyer –Greenpeace. ### Multi-stakeholder Dialogue:

A fundamental part of the conference is a multi-stakeholder dialogue in which different actors discuss their views on the opportunities for renewables. The MSD has an International Advisory Group, which are assisting in the development of positions from the ten identified stakeholders and then will work to develop two themed positions at the Conference itself. NGOs are one of the ten defined stakeholders. The NGOs representatives are: Jennifer Morgan – WWF International; Jurgen Maier/Setphen Karekezi- Cures network; and Jorg Haas –Heinrich Boell Foundation.
